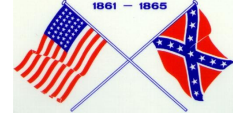

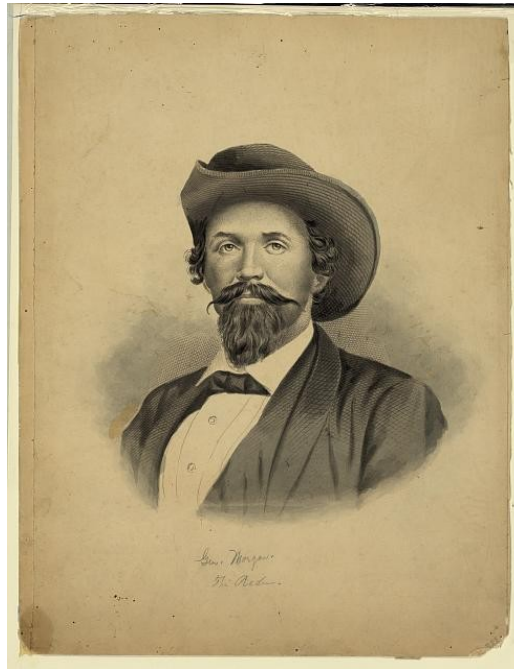

 Confederates in Indiana – Indiana and the Union Respond

This session will focus more on the defense mustered by the Federal Government and the State of Indiana in response to the 1863 Indiana-Ohio Raid. Of interest is an attempt to track the activities of General Lew Wallace and Governor Oliver P. Morton, General Burnside, Union Cavalry and Indiana Legion units among others. Personal and family anecdotes about Morgan's stay in Lexington, Indiana will be included. Resources include Wallace himself, the Governor's report to the General Assembly, Morton's Memoirs, a Historic Southern Indiana Audio Tape and recent books by Horowitz and Stephens, to mention two. A complete bibliography will be provided.

### *Our Guest Speaker*

Presenter **Jim Turley's** pioneer ancestors settled in the Lexington-Nabb Indiana area during the second decade of the 19th Century. Those living in the Lexington, Indiana area in 1863, supplied family stories of their experiences during the Raid.

Jim Turley grew up in the Lexington, Indiana rural community. He is a graduate of Scottsburg High School and Purdue University. His military career began in June 1956 when Jim joined Company D, 138th Tank Bn., Indiana National Guard. He received a BS in Agriculture from Purdue and an MBA from Babson Institute. His Army commission resulted from completion of four year Army ROTC at Purdue. His service as an Army Transportation Corps officer spanned nearly twenty three years, ending in 1984 when he finished assignment as Head of the Army ROTC program at Purdue. Now a Purdue staff retiree, Jim has been involved with the Tippecanoe County Historical Association, Lafayette, Indiana Civil War Roundtable, Wabash Area Lifetime Learning Association, and military and veteran organizations, including alumni support of ROTC units at Purdue. He and wife Mary Jo are parents of three grown children.

### **With Hood's Texas Brigade in Virginia Earning their Reputation, 1861-1862**

**Sesquicentennial Tour:** Join Ed Bearss, Susannah Ural and other noted historians for three days in the footsteps of the brave on June 26-29, 2012. This tour is sponsored by the Hood's Texas Brigade Association, Re-Activated (HTBAR). Membership in HTBAR is not required. Advance as Hood did at Gaines' Mill to secure Lee's first victory. ### *The Soldiers Speak*

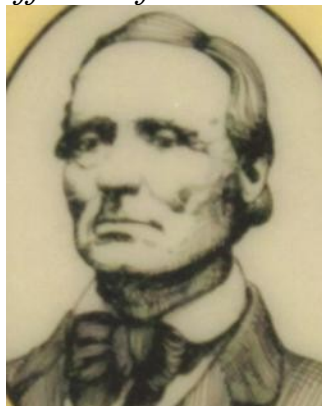
Sergeant Henry Stone (a boy from Greencastle, Indiana, who had joined Morgan's raiders, in a letter to his father, written July 8, 1863, after stepping onto Indiana soil: "Wake up old Hoosier now. We intend to live off the Yanks hereafter and let the North feel like the South has felt some of the horrors of war – horses we expect to take whenever needed, forage and provisions also. In fact it is concluded that living is cheaper in Indiana and Ohio than Tennessee...I hope I'll get close enough to pay you a visit. This will be the opportunity of the Northern people seeing Morgan and they'll see enough. I just imagine now how the women will bug their eyes out at seeing a Rebel army."

Governor Morton's state of emergency warning: "In order to provide against possible danger it is requested that all places of business in Indianapolis be closed this afternoon at three o'clock, and that all ablebodied white male citizens will form themselves into companies and arm themselves with such arms as they can procure, and endeavor to acquaint themselves with military tactics."

The response of the Darlington Home Guard to Morgan's raid: "A company of sixty men were formed in Darlington under command of Captain E.P. McClaskey....This company was called the Wallace Blues in honor of Captain Lew Wallace, Indiana's Adjutant General in charge of raising and organizing troops....In 1863, the mothers, wives, sisters and sweethearts of these men decided to present the company with a flag and chose July 4<sup>th</sup> as the most appropriate time....When the flag presentation was taking place in Darlington, General Morgan was striving to cross the Ohio river and enter Indiana. Four days after receiving the flag, the Wallace Blues were ordered to Mitchell to assist in driving Morgan from the state, and quite proudly they marched forth beneath their new banner....After this company of men returned from helping check Morgan's raid, many of them enlisted and went to the front, and through the remainder of the war served with credit to the state."

A Corydon defender stated: "...the enemy opened upon our forces with three pieces of artillery, making the shells sing the ugly kind of music over our heads....In the meantime the enemy had completely flanked the town...the fighting was very sharp for the space of twenty minutes....After the field was taken by the enemy they moved forward, and planted a battery on the hill south of town, and threw two shells into the town, both of them striking near the center of main street, one exploded but did no damage. Seeing the contest was hopeless...Col. Jordan wisely hoisted the white flag and surrendered."

#### Find a Grave

From the Corydon Battle Park website: “The home guard, under **Colonel Lewis Jordan**, had drawn a battle line behind a hastily thrown up barricade of logs. In a short but spirited battle, lasting less than an hour, Morgan met his first and only organized resistance in the Hoosier State. By outflanking both wings at the same time, Morgan's men completely routed the militia. Four of the guards were killed, several were wounded, 355 were captured, and the remainder escaped. The victory was not without cost to the Raiders. Eleven Raiders were killed and 40 were wounded.”

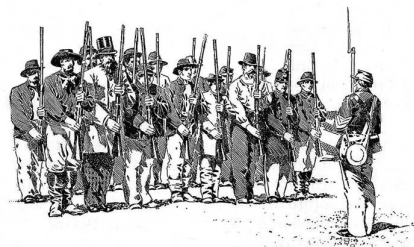

From Corydon Battle Park website: “The **Battle of Corydon** was the only Civil War Battle fought on Indiana soil and occurred on July 9, 1863 when 450 members of the Harrison County Home Guard attempted to delay General John Hunt Morgan's 2,400 Confederate soldiers that day, in hopes that Union reinforcements would arrive and stop Morgan's march through southern Indiana.”
