

Please note that we are meeting in a Classroom at the Indiana History Center this month. There will be signs directing you to the location on the Canal level of the building.





Lew Wallace is a controversial citizen-soldier whose battlefield performance ranged from dismal to brilliant. Let's look at the types of decisions he made early in the war as well as

the complexity of decisions he made at Monocacy. He remained a political general, unlike Joshua Chamberlain, due to early responsibility beyond his ability. His early war experience in West Virginia and his steady performance at Forts Thomas and Donaldson made him a candidate to be Grant's right arm as Sherman was the left. Why did his action at Forts Thomas and Donaldson give no indication of his future failure at Shiloh? Did you know Lew Wallace later protected Cincinnati by challenging Bragg with a mob? Let's walk in the boots of a famous Hoosier who after the war won fame and fortune. Hear how he learned to be an effective but limited battlefield leader - a losing winner.

The workshop will be held May 17 and 18 at the Spring Valley Cemetery in Lawrence (northeast side of Indianapolis, near Fort Benjamin Harrison State Park). **Civil War Days:** Conner Prairie will hold Civil War Days on May 18-19, 2013. Admission to Conner Prairie is: \$15 adults; \$14 seniors 65+, \$10 children 2-12, free to children under 2 and for active and retired military (with military ID); and 50% off for immediate family of active and retired military members (rates for March 28 – Oct. 31).

**The Filson Civil War Field Institute:** The Filson Historical Society will host another Civil War Field Institute (using field trips and lectures) to explore East Tennessee in Turmoil on June 6-8, 2013. They will stay in Greeneville, Tennessee and visit: the East

Tennessee Historical Society Museum in Knoxville; Bijou Theater (the location of the Lamar House, which was a center of secessionist activity); Fort Dickerson; Battle of Blue Springs; Bleak House (Longstreet's 1863 headquarters); Old Gray Cemetery; Dickson-Williams mansion (where John Hunt Morgan spent his last night before his death); Andrew Johnson National Historic Site; follow the old railroad route and stop at the bridge burning sites as they leave Greeneville; Cannonball House; Sinking Spring Cemetery (where Morgan was first buried and John Floyd is buried); Saltville-Battlefield Tour; and the depot where the Pottertown bridge burners were hanged. The tour guide will be Brian D. McKnight, Associate Professor of History at the University of Virginia's College at Wise. Cost is \$280 for Filson members and \$330 for non-members. This includes all admission fees to museums and parks, chartered bus, two lunches, a reception and Thursday evening dinner. All participants are responsible for their transportation to Greeneville, their hotel accommodations, and Friday dinner. #### Battery Wagner Commemoration (from Ft. Sumter-Ft. Moultrie Trust Newsletter):

"The battle of Battery Wagner on Morris Island will be commemorated July 18-21 as part of the Lowcountry's continuing observance of the Civil War Sesquicentennial. We are planning a series of events in and around Charleston in partnership with the SC Battleground Preservation Trust, the 54th Massachusetts Regiment, the National Park Service, municipal governments, and others. Conceptual plans include scholarly lectures, living history displays at Fort Moultrie, a historical marker, reenactments on Morris Island, a concert, and screenings of the movie *Glory*." Another place you might want to visit in this area is the Charles Pinckney National Historic Site, 1254 Long Point Rd. near Boone Hall in Mt. Pleasant (free entrance). **Flag Preservation Update:** The Governor signed Senate Bill 0323 on April 8, 2013. This bill, which renames the Civil War flags fund as the Indiana battle flags fund so that money in this fund can be used to restore and preserve all Indiana battle flags, will go into effect on July 1, 2013.

*Copperhead*: This new film by Ron Maxwell, the director of *Gods and Generals* and *Gettysburg*, is about Abner Beech, a farmer in upstate New York, who is against slavery but opposes the war Lincoln is waging for constitutional reasons. ## The Soldiers and Civilians Speak

Corporal Nicholas Hagerman, Company D of the 14<sup>th</sup> New Jersey, described the blockhouses built to protect Monocacy Junction: "Thay are agoing to build what thay call Block houses to defent the Bridge thay are built out of logs and are 8 Square thirty feet on each Square with loop holes to Shoot through in case thay come to distroy the Bridge Thay are agoing to build two of them."

Private Samuel McLain, musician in 144<sup>th</sup> Ohio National Guard, described events before, during and after the battle: "July 7 [1864]: We left Camp Parole at 2 o'clock. We arrived near Harpers Ferry [Monocacy Junction] at 12 o'clock... I think the Rebs will not fight.

July 8: We can hear the battle [west of Frederick, Maryland]. We started after Johnny Rebs after midnight.

July 9: 2 o'clock. The battle is raging fiercely. 4 o'clock. The Rebs are driving our men, oh my God we have to retreat. We are striking for Baltimore. Our men are getting all cut

to pieces. The artillery has left. I must go. Every man must save themselves. We have 45 miles to retreat.

July 11: We arrived in Baltimore or part of us ... We march all night and until 2 o'clock the next day. We have had a hard march. My feet are all raw ... I am well but sore feet ... We had to [throw] all our baggage away and guns. I stuck to my drum and grub. We got no sleep for three nights."

Mamie Tyler Gatchell was hiding in the cellar of the Thomas Farm during the battle: "Pieces of shell were flying too near to be pleasant ... Minié balls slashed the shubbery, while the larger missiles of War's fearful instruments twisted huge limbs from the trees, leveled down chimneys, & tore out an angle of the house."

Sergeant Ervin Dunbar, Company H of the 10<sup>th</sup> Vermont, visited the battlefield with his sons in 1913 and wrote the following to fellow soldier Private George M. Douse, who was seriously wounded during the battle: "... I started out for the field..., walking over the new iron pike bridge and along the Washington Road. Some changes in the fields and fences have been made. The trees all about are larger and therefore things have changed some; but when I made it a study to get at the location of our little army, took in the situation fairly well. The river is much larger than I had supposed, and [I can] see why our men could not cross in only at the bridges. I do not know how long you were with the regiment [on] the 9th as at some time you went on the skirmish line, so [I] will tell you now about the regiment....In the morning we would [come] down from the hill to the south side of the railroad on a low flat not far from the mill; [then moved] after to the left a short distance and supported a section of artillery and got shelled a little - no one hurt, I think. In rear of us near the woods and lower down the band boys got shelled a little and so moved out briskly. While here, men began to come in from the front wounded. From this position, we went to the left and formed an extended line of battle along the Washington [Georgetown] pike....We found these spots or places where the regiment fought. Could stand and see these places all at once so you see the field was small. ... We did not get the time to go over the line on which we retreated nor out on the dirt road where McCausland and Gordon pushed our men back and came over the river. Hard fighting was done here. Gordon tells that the river ran red with blood. Perhaps I have told too much of this place...."

## Civilian of the Month

**John Work Garrett** was born July 31, 1820 in Baltimore, Maryland. As president of the B&O Railroad, he played an important role in protecting Washington, D.C. He sent several telegraphs to Secretary of War Edwin Stanton to warn him that Confederates were moving toward Washington. The Union failed to take action until he contacted Major General Lew Wallace. Garrett used his railroad to move troops as Wallace strengthened the Union position at Monocacy. Lincoln paid the following tribute for Garrett's role: "The right arm of the Federal Government in the aid he rendered the authorities in preventing the Confederates from seizing Washington and securing its retention as the Capital of the Loyal States." Garrett died September 26, 1884 and is buried in Green Mount Cemetery in Baltimore, Maryland.
