# *The Plan of the Day* U.S. Christian Commission

The United States Christian Commission was a Christian organization founded by the YMCA and started during the Civil War about 1862. Its sole purpose was to minister to the soldiers and make sure they did not go into eternity without a chance to get their heart right with God. The need for chaplains was soon realized, and a call went out and over 5,000 chaplains responded. They started passing out Bibles and handing out Gospel tracts to the troops. They would also go into the churches of the towns and gather food to take into the camps. The Christian Commission also helped in the hospitals and cared for the sick and wounded no matter whether they wore blue or gray. D.L. Moody was noted as saying that "God sees no color nor do I." He is noted as preaching a service for the Boys of the North on Monday and a service for the South on Wednesday. He walked wherever he went and when he came upon an encampment, he held service. As the war went on, there are several stories where the boys would be in services in camp. One story tells of the boys standing outside in the winter in the snow in their socks trying to hear the chaplain bring a message. And another of the stories tells of General Jackson having a chaplain hold services for twenty-four hours until every one of his boys heard the Word at least once.

#### The Civilians and Commander-in-Chief Speak

John C. Chamberlain, USCC representative at Gettysburg: "I soon found myself driving stakes with a rock and twisting every spare corner of their bedding over them. My success started others and soon I had the comfort of seeing the whole hospital in the shade....After all, my dear sir, our labors at such times are of such a nature that we can give but a faint idea of them on paper. There are a thousand little nameless acts which the world cannot know, nor we ourselves recall, that are nonetheless important in their issues." – "Civil War Christian Commission Was Formed – 1801-1900 Church History Timeline," accessed 18 April 2013, <u>http://www.christianity.com/church/church-history/timeline/1801-1900/civil-war-christian-commission-was-formed-11630528.html</u>.

Edward W. Hotchkiss, USSS: "When I left for the [seat] of our late war on the Christian Commission, I said to my congregation, I am going to the war, going to stay six weeks, going to see the end of the war, going to Richmond, & going to return to you safe & well at the end of the 6 weeks. All of which came to pass as foretold. This was without any relative thought one minute before it was spoken." – "Civil War Diary of Edward W. Hotchkiss," accessed 18 April 2013,

George Hay Stuart, chairman of USCC: "I have prayed for this union, and I have labored for it, simply because I believe that it would bring glory to my blessed Lord and Master, Jesus Christ....I have labored and prayed for it, because it would bring brethren together, now unhappily divided, to see eye to eye, that the nations that have so long bowed down to idols might learn of Jesus and Him crucified...Since these twenty four hours have passed away, eight six thousand four hundred immortal souls have gone to the judgment seat of Christ....I never hear the funeral bell toll without asking myself the question, what have I done to point that departed soul to the Lamb of God that died to save a perishing world?...Brethren, buckle on your armor for a great conflict; buckle it on for giving the glorious Gospel of the Son of God to the millions of the earth who are perishing for the lack of knowledge." – "Original Christian Commission," accessed 18 April 2013, http://www.nwuscc.org/OldUSCC.html.

Abraham Lincoln, December 12, 1861: "Your letter of the 11<sup>th</sup> inst and accompanying plan, both of which are returned as a convenient mode of connecting this with them, have just been received. Your Christian and benevolent undertaking for the benefit of the soldiers is too obviously praiseworthy to admit any difference of opinion. George Hay Stuart served as chairman of the USCC during the Civil War. The goal of this group was "to promote the spiritual and temporal welfare of the soldiers in the army and sailors in the Navy, in cooperation with the Chaplains." They published collections of hymns, Bible readings and prayers; held devotional meetings in camp; aided the chaplains; and handed out over 30 million gospel tracts and New Testaments to the soldiers. They also helped with wartime relief: "the promotion of the intellectual, moral and religious welfare of the Army and Navy, buy suggesting needful national legislation and administration, securing well-qualified chaplains, encouraging Sabbath observance, promoting temperance, multiplying libraries, reading-rooms, and gymnasiums, and endeavoring to arouse the nation to a sense of its obligations to this class of citizens."


